

## SECTION 6 Dt. 7/26/2023 Guideline Rules & Regulations for On-line Reverse Auction (RA)

	General Terms and Conditions governing conduct of On-line Reverse Auctions		
1	Brief description of the tender processing for On-line Reverse Auction is given below:		
1.1	The mjunction would intimate Date & Time for Start of Reverse Auction & duration of auction to the Bidders in advance. Login ID & Password specific to each Bidder is given and demonstration of bidding (On-line) process is given to enable each Bidder fully understand the process of bidding On-line.		
1.2	Thereafter, at scheduled time the screen for On-line bidding is launched wherein the Bidder would put in their best offers through On-line bids in which the Start Bid Price can be reduced by the Bidders to secure orders for the supply of items/services.		
1.3	All eligible Bidders having password can view the bidding screen after acceptance of online declaration on the computer screen and also enter their prices any number of times during the duration of bidding.		
2	REVERSE AUCTION: ROLE OF SERVICE PROVIDER & BIDDER		
2.1	Steel Authority of India Limited (All Plants/ units) have engaged the services of its Joint Venture Company M/s mjunction Services Limited (MJ) for conducting the Reverse Auctions of Goods & Services. The purpose of such Reverse Auction would be to meet SAIL's requirement for item(s)/service(s) from the Sellers / Bidders desiring to sell the item(s)/service(s) to SAIL. The contact details of the mjunction shall be provided by them in the Auction Notice issued by them. mjunction is authorised to give clarifications regarding the reverse auction process to Bidders on behalf of SAIL.		
2.2	,		
	Reverse Auction  A reverse auction is an auction in which the traditional roles of buyer and seller are reversed.  Thus, there is one buyer and many potential sellers and the sellers compete to sell items/ services to the buyer. The sellers are required bid downwards i.e., underbid each other to win the contract.  On-line Reverse Auctions		
	Reverse Auctions which are conducted through the Internet with simultaneous bidding by the bidders (from one or more locations). In other words, the venue for the auction is on an Internet website/ platform. The mjunction website https://auction.buyjunction.in or any other URL assigned by mjunction would constitute the venue for the purpose of the on-line auction.		
	Award at the Reverse Auction		
	The bidder quoting the lowest price is declared the L-1 bidder for the item/service to be procured.		
	Client		
	SAIL who has contracted with mjunction to conduct the Reverse Auction.		



#### **General Terms and Conditions governing conduct of On-line Reverse Auctions**

#### **Bidder**

Individual/business entity participating in the Reverse Auction, intending to supply the item(s)/service(s)to the Client which has to secure Client approval for participation and provide written acceptance to the General Rules and Regulations.

#### **Auction Engine**

The software that encapsulates the entire auction process, processing logic and information flows. mjunction is the sole owner of the auction engine and retains exclusive right over the utilization of the same.

#### **Preview Time**

Preview Time refers to the period of time that is provided prior to the commencement of bidding.

#### **Start Time**

Start time refers to the time of commencement of the conduct of the On-line auction.

#### **Duration of the Reverse Auction**

It refers to the length of time the price discovery process is allowed to continue by accepting bids from competing bidders. The duration of the auction would normally be for a pre-specified period of time. The same may however be subject to bidding rules.

#### **Auto Extension of the Auction Timings**

In the event of bids received in the last few minutes of the scheduled bid time, the Bid Timings are automatically extended for a specified period from each such bids placed. Such Auto Extension shall continue until no bids are placed for the specified period (i.e., the auction engine remains inactive for the specified period). The Inactivity Time for Auto Extension purpose is normally 5 minutes. mjunction however retains the right to change the same. The Inactivity time applicable for the particular On-line Bid shall be communicated to the bidder before the bidding process starts, if it is set for less or more than 5 minutes or more.

#### **End of the Reverse Auction**

Termination of the bidding event signaling an end to the price discovery process.

#### **Auction Report**

Report provided by mjunction containing a summary of the bidding event and outcome.

#### **Start Bid Price**

Price decided by the client from where the auction starts which would be put up on the site before commencement of Reverse Auction and also communicated in advance to all the

	Minimum Decrement				
	Minimum decrement is the minimum amount a Bidder has to reduce in order to place its bid.It shall be specified in each case prior to start of Reverse Auction This minimum decrement shall be pre-decided by Client and will be in- built in the auction engine. (For cases where foreign bidders are bidding in Landed Cost Net of input Tax credit (LCNITC) & Indian Rupee (INR) (Currency Conversion will be rounded off to the nearest whole number)				
3	Process of On-line Reverse Auction:				
3.1	For tenders issued by SAIL plants/ units, bidders submit their Techno Commercial (TC) bids and the price bids, on or before the due date of tender opening. The price bids shall be submitted by the Bidders online on the SRM platform / EPS Platform or on the buyjunction platform of mjunction as stated in the RFQ terms. In case price is submitted on buyjunction platform of mjunction, a system generated acknowledgement of submission of online sealed price bid submitted prior to TOD on the buyjunction platform of mjunction, which is to be submitted with the TC Bid. The process for submitting online price bid on the buyjunction platform of mjunction is placed at <b>Annexure A.</b>				
3.2	In case SAIL Plants/Units decide to conduct Reverse Auction , SAIL Plants/Units shall inform mjunction about all bidders whose offers are found techno-commercially acceptable. These techno-commercially acceptable bidders shall become eligible for participating in price bidding through On-line Reverse Auction. SAIL Plants/ Units shall intimate the list of Techno-Commercially acceptable Bidders to mjunction.				
3.3	All eligible bidders having ID & password can after connecting view the bidding on the computer screen and enter their prices any number of times during the duration of RA event.				
3.4	The L-1 price matching will not be done in the RA event. If Price matching is required to be done, the same will be done by mjunction after finalisation of L-1 price by SAIL Plants / Units.

- **e.** New bidder would have to click the link "New User" which would then throw open a pop-up screen showing details on how to (a) register online (b) receive user ID/password on their registered email with which they have registered online and (c) place their bids. With this, new bidders would also become enabled to log in and participate on mjunction e-platform.
- **f.** After logging in (with respective user IDs/ passwords), bidders shall be directed to a web-page where detailed road map (user manual) on how to place bids would be displayed.
- **g.** Each bidder can login and place/register a sealed price bid on mjunction e-platform within the stipulated period stated in point 'c' above.
- **h.** Each bidder shall be provided with a system generated acknowledgement of submission of online sealed price bid submitted prior to TOD on the buyjunction platform of mjunction which can be printed.
- i. In case any vendor submits online Price Bid but the Techno-Commercial bid has not been submitted on or before Tender Opening Date(TOD), such online Price Bids will not be considered by SAILPlant/Unit.

- a) A hammer sign on your screen reflects that you are leading bidder (L1) at that moment. The hammer sign may disappear from your screen depending upon the progress of the online event. In case hammer sign disappears from your screen it implies that you are not L1 bidder currently & you need to revise your bid to become the L1 bidder.
- b) For Rank Bidding: If your Rank is displayed as 1 that means you are the leading bidder at that time whereas if it is 2 or above then you have to revise your bid to improve your rank. There can be tie bid in all ranks other than Rank 1. In-case of tie bid your rank will be displayed as per the time of placement of your bid. (For example L1 rate is Rs 90, if Bidder 2 has quoted Rs 100 at 04:00 PM, Bidder 3 has quoted Rs 100 at 02:30 PM and Bidder 4 has quoted Rs 100 at 4:03 PM then system will show their ranking as below.
  - 1. Bidder 3 will be L2.
  - 2. Bidder 2 will be L3.
  - 3. Bidder 4 will be L4.

Please note that either Hammer or rank will be displayed only during auction for all auction rules except online price bid at techno-commercial stage and price match stage. *In online price bid no status other than bid acceptance confirmation would be displayed.* 

**Start Bid Price:** Start bid price is the starting point of the auction, the bidder has to quote lower than the start bid price, for the price to be accepted by the auction enginein reverse Auction/Rank Bidding

Only in certain cases where discount (in value or percentage) has to be quoted , then the bidder has to quote higher than the start bid price

12.5 Minimum Decrement: Minimum decrement is the minimum amount by which, a bidder has to reduce his bid value in order to beat the latest lowest bid. For example, if a bidder bids Rs 10,00,000/ - for a market, others, in order to beat this bid, have to quote a lower price with a minimum decrement say of Rs.2,500/- i.e. in order to be able to submit next valid bid, they have to quote Rs. 9,97,500/- (or lower) for the same market. This minimum decrement shall be predecided by SAIL.

Depending upon the auction strategy Bidder may be able to provide decrement in multiple of minimum decrement amount or may be able to reduce any value higher than minimum bid decrement.

For Rank bidding event (dynamic price negotiation) Bidder has to reduce his bid from his last quoted bid

- **12.6 Current market Price:** Current market price is the lowest price in the auctionat any point of time and will be displayed during the reverse auction. Bidders would be able to see the current market price once any bid is received in the market.
  - a) Bidders will be allowed to quote a bid less than current market price or
  - b) In case of rank bidding, current market price will not be visible to the bidders and bidders will be allowed to quote a bid less than their own last quoted price

**Proxy Bid Submission:** - Proxy bid facility safeguard bidders from any connectivity issue, infrastructure failure (like: power, link, slow speed, computer etc.) during auction. Proxy bidding also helps when multiple markets/auctions are running simultaneously. <u>Proxy facility works in following manner:</u>

Process to set proxy bid you're your best bid value is as follows:

- a. Place your desired proxy bid amount in 'new bid box'.
- b. Click on the 'Proxy' bid check box.
- c. Click on the 'new bid' Box available at the extreme left hand side of the market.
- d. Click on the submit button available on the bidding screen.

Once a proxy limit is set, system automatically bids on behalf of the bidder by reducing one decrement compared to the current market price. Thus it ensures that bidder who has activated proxy will be the leading bidder (L1 bidder) till the proxy limit is reached. Your Proxy bid value is neither known to your competitors nor to mjunction. It remains undisclosed at the back end of the system. System will continue to revise your bid in stipulated decrements; so long it receives a revised bid from any competitor. In case the system does not receive any revised bid and the market ends, you will be the L1 for that market at the market price prevalent at the time of closure. Even in-case(s) of tie bid (i.e. proxy bid activated from your side and normal bid of that same amount is placed by your competitor), your proxy bid will be declared as lead bid for that time being for that particular market since you have activated proxy bid and your competitor will be shown outbid message.

**Note:** Proxy bid submission facility can be utilized only in standard reverse auctions (i.e. reverse auctions without template/factor/loading or premium discount /Rank Bidding).

Proxy bid example: Say Reverse auction stage has started with the Start Bid Price of 200 INR and Bid decrement of 5 INR. You have activated a proxy of 150 INR at the very beginning of the event. In such scenario when even competition place a bid, system will itself place a bid on your behalf which would be one decrement lower than the competitor's bid value & ensure that you would be L1 bidder for the market.

Say with due competition market price has gone down and presently it is at 165 INR, your competitor places a normal bid of 150 INR. System will display 'outbid' message to the competitor for their bid of 150 INR and your bid of 150 INR will be declared as lead bid at that instance of time till any other bid lower than your proxy bid gets registered in the system before closure of runtime of auction.

#### 12.8 Warning & Bid rejection message:

To prevent incorrect bid submission due to oversight, following system checks are available in the system for all auction:

- a. Warning Message: In case of a quoted bid by any bidder is 10% or more lower than the Current market price, system displays a warning message to bidders indicating that their bid is 10% or more lower than the current market price in a pop- up window. In this scenario, bidders will have the option to either accept the bid & go ahead with bid submission or edit their bid.
- b. Rejection message: In case of a quoted bid by any bidder is 50% or more lower than

the current market price, system will reject the bid & bidders will see a corresponding message on bidding screen indicating that the bid value is 50% or more lower than current market price. In such scenario, bidder(s) need to revise their bid if they are interested to quote for the market.

Bids may also be rejected in some other scenarios & reasons for such rejection will be displayed on the bidding screen automatically as well as the reason for rejection is also available in the training module. Also such reasons can be viewed by clicking on the 'rejected' status link during online auction. Bidder are expected to read the reasons carefully & act accordingly to correct their

- 1. For Rank bidding, above mentioned check will be done from bidder's last quoted bid instead of Current market price.
- 2. For first bid in any markets, 10% & 50% checking will be done from start bid price.
- **12.9** Auction 'Pause' Timing:-In case an auction continues beyond 8 P.M (IST) on a particular day from Monday to Friday, then the same may be paused on that day and may be reopened on the next working day in a specified time as per official communication from mjunction. For an auction scheduled onSaturday, in case the auction continues beyond 6 P.M (IST) then the same may be paused on that day and may be reopened on the next working day.
- **12.10** Auto Extension of Bidding Time: Only in the event of any bid being placed(Valid & accepted Bid) in the last #@TIME\_EXT@# minutes of the scheduled bidding time, the bidding time shall automatically extend by #@TIME\_EXT@# minutes from each such bid. This Auto Extension mechanism remains activated until a continuous inactivity period (i.e. no bids being placed by any bidder) of #@TIME\_EXT@# minutes is reached at which point the market shall close
